#### 1. DECLARATION OF CONFLICTS OF INTEREST

#### 3. **DELEGATIONS**

#### 3.1 <u>Facility Needs Assessment – Mr. Jamie Vandyk of Walter Fedy</u>

Mr. Vandyk presented his report which included an immediate action plan to address space and program pressures in the building, with minimal costs, as well as a short-term plan to address more substantial changes to lengthen the life of the 22-year old facility. He also provided information on possible expansion opportunities for the next five to ten years.

Deputy Chief Nelson indicated the recommendations would be included in the capital forecast.

## 3.2 <u>False Alarm Reduction Strategy – Constable Robin Butterfield</u>

Constable Butterfield provided a presentation on a false alarm reduction strategy, indicating that in 2012, 2,627 alarms were responded to, of which only 42 (or 1.6%) were found to be valid. He indicated that almost 70% of the false alarms are repeat offenders. He stated that in 2012, 2,284 man hours were lost to false alarms, costing \$94,000 in officer time. Constable Butterfield pointed out that alarm companies are often making no attempt to contact property owners or other key holders to verify if an alarm is real or false, but calling police.

A recommendation was received that all alarm systems in the city be registered, with residential and commercial property owners with alarms paying a \$25 registration fee. He also recommended that false alarms be billed to the alarm companies, not the alarm holder.

WHEREAS the Brantford Police Services Board has received a presentation this date on a strategy to reduce the number of false security alarms

AND WHEREAS staff has recommended the Board create a bylaw to establish a system for the registration of security alarm systems that imposes fees and charges for services provided by the Brantford Police Service in relation to false alarms

NOW THEREFORE BE IT RESOLVED THAT in an effort to reduce the number of false alarms the Brantford Police Services Board directs staff to prepare a draft bylaw for consideration.
