#### 4.2.3 October 2017

Deputy Chief Dinner provided a brief overview of this report, indicating that Sexual Assaults had risen year over year from 12 to 28 incidents, and explained that one individual had been named in a number of historical incidents. Further, he noted that all break and enter offences had decreased, while robbery offences remain consistent. He was pleased to note the decrease in auto theft. He related again this month that employee absenteeism continues to increase significantly over the past year.

## 4.3 Monthly Budget Report

Chief Nelson presented this report for the period ending February 27, 2018. He indicated he had no concerns with the budget.

## 4.4 2017 Annual Reports

#### 4.4.1 Suspect Apprehension Pursuits

Inspector Steve Sumsion presented his report, which outlined all Fail to Stop incidents, as well as initiated pursuits involving Brantford Police Service officers. He stated that 58 Fail to Stop Reports were submitted. Of these reports, three resulted in a pursuit being initiated. He commented that it is important to note that officers did not engage in a pursuit during 55 (or 95%) of fail to stop incidents. Two pursuits were discontinued by the pursuing officer, while the remaining pursuit was terminated by the NCO, all in the interest of public safety.

He stated that the five-year average for pursuits initiated by the Brantford Police Service is 7.6. Pursuits in 2017 represent a 60% decrease from the five-year average.

Additionally, in 2017, no injuries or motor vehicle collisions resulted from police pursuits.

Inspector Sumsion indicated the pursuit policy and reporting procedures were thoroughly reviewed as part of the annual process and no deficiencies were found.

# 4.4.2 Accessibility Report

This report, prepared by A/Inspector R. Paolini, was received. The report indicated that in 2017, the Board approved a new five-year Accessibility Plan that identified standards to be addressed by 2022. It was noted the accessibility standards for the built environment have been taken into consideration in the planned redesign of the off-street parking and new path of travel at 344 Elgin Street.

#### 4.4.3 2016-2018 Business Plan Review

Chief Nelson presented this document, prepared by Inspector Paolini, which reported on the 53 performance objectives, indicators and 2017 results of the 2016-2018 Business Plan.

Chief Nelson advised that information obtained from the service delivery review which is currently underway, will be used in the development of the 2019-2021 business plan. He recommended that the Board defer the development of the next Business Plan until the service delivery review results are received.
