4. REPORTS

4.1 <u>Issues Update – Chief G. Nelson</u>

Chief Nelson reported that the Service was taking applications for participants in the upcoming 20th Citizens' Police Academy. He also informed the Board that confirmation had not yet been received on the status of Provincial grants which total over \$2 million.

He spoke of an incident of a lost 8-year old child and the compassion shown by Csts. Archi and Batson and how proud he was of the officers.

He reported that since October 17, 2018, the Service had received 113 cannabis-related calls for service, 91% of which required response by front-line officers.

4.2 <u>Statistical Reports</u>

4.2.1 Monthly Reports – May and June 2018

These reports were received. Deputy Chief Dinner indicated the issue of timeliness of the reports was the result of staffing shortages in Records.

4.3.1 2018 Fourth Quarter Report

Inspector Donald Pancoe presented his report. He indicated that since the report had been compiled, new information has been received that the 2018 surplus will be \$834,281.

4.3.2 Capital Project Financials

Inspector Pancoe presented his report of January 29, 2019, in which he sought the approval of the Board to close the Renovation Furniture capital project and move the allotted amount into Minor Capital reserves. He noted that given the recent review of the current facility and the proposed recommendation for construction of a new facility, these funds will not be required at this time.

4.5 High School Resource Officer Program Meeting with Boards of Education

Vice Chair Brendan Ryan reported that he and Chief Nelson had met with Mr. Wayne Baker of the Grand Erie District School Board and Mr. Mike McDonald, Superintendent of Education with the Brant Haldimand Norfolk Catholic District School Board on January 9, 2019, to discuss funding for this program.

He indicated that the time officers are devoting to the program has been diminished due to manpower demands. The Board of Education representatives were asked to consider providing funding for the High School Resource Officers. All agreed that the program was effective and beneficial to all. The representatives indicated they would recommend this funding to their respective Boards of Education.

Chief Nelson reported that he had been advised that the Grand Erie District School Board turned down the funding request; however, the Catholic School Board would be moving forward to recommend the funding of one officer to the trustees.

Chief Nelson reported that work was continuing on the review and that Met-Scan staff was meeting with focus groups. The consultant has been invited to provide a presentation on the status of the Review at the March Board meeting.
