5.1 Statistical Reports

5.1.1 Monthly Statistical Reports – June, July and August 2012

5.1.2 Five-year Semi-Annual Statistical Report

Deputy Chief Geoff Nelson highlighted point of interest in the report, noting that the sexual offences, assaults and robberies with a weapon decreased over the last year. He pointed out that when looking at trends over five years, motor vehicle thefts and attempts, frauds and offensive weapons are decreasing. In respect to administrative statistics, he indicated that overtime for court is rising at a significant rate, along sick leave.

5.2 Quarterly Budget Report

Chief Kellner reviewed the Quarterly Budget Report for the period ending September 1, 2012. He noted there was a surplus of \$49,397, but anticipated that number would be higher as some grant funds had not yet been received.

5.3 Quarterly Auction Proceeds Account Report

This report, for the period ending June 30, 2012, indicated an account balance of \$45,322.67.

Chief Kellner reviewed this report, indicating that a number of complaints had been closed off over the summer.
