#### 1. PRESENTATIONS/DELEGATIONS

# 1.1 Police Exemplary Long Service Awards

Constable Jason Nagy was presented with his 20-Year Police Exemplary Service Medal. Inspector Kent Pottruff was then presented with his Police Exemplary Thirty-Year Bar. The officers were thanked for their service to the community.

#### 4. REPORTS

## 4.1 <u>Issues Update – Chief G. Nelson</u>

Chief Nelson reported that a comprehensive review by OMERS was being undertaken to ensure the viability of the pension fund. He continued that no changes to the plan would take place before January 1, 2021.

He was pleased to report that the COPS (Citizens on Patrol) Program recognition event was held June 20 for the 73 volunteer members. He commented that this effective program was valuable to our community.

He further reported on a successful gun amnesty event which was held in the spring.

### 4.2 Monthly Statistical Report

Deputy Chief R. Dinner highlighted points of interest in the February 2018 report. Of note was the rise in thefts of motor vehicles from 30 to 55, year over year. He pointed out the decrease in impaired drivers from 13 in February 2017 to 3 in February 2018. A significant increase was noted in motor vehicle accidents, from 188 in February 2017 to 242 in February 2018. He noted an increase of 500 in calls for service year to date over 2017. Of concern was also the ongoing increase in overtime and WSIB absences.

#### 4.3 Monthly Budget Report

Inspector D. Pancoe attended and presented his budget report for the period ending May 31, 2018. No areas of concern were noted.

#### 4.4 <u>Income Services Report</u>

A report dated May 31, 2018, was received from Inspector D. Pancoe, recommending changes to the fee schedule.

THAT effective January 1, 2019, the Fee Schedule be amended to include:

i) an increase of \$5.00 to each police check as follows:

PCRC - Employment to \$35.00 PIC - Employment to \$40.00 PVSC - Employment to \$45.00

ii) an increase to the Records Suspension fees from \$30.00 to \$50.00 + HST, which is in line with comparators.

# 4.5 Request for Financial Assistance – Children's Safety Village

A letter had been received from The Children's Safety Village requesting ongoing funding for \$10,000 annually. Chief Nelson indicated he was in meetings with representatives of the Village and he would supply a report with a recommendation. This item was deferred until the report is received.

#### 4.6 2017 OPP Activity – Brantford Policing Jurisdiction

Correspondence was received from Commissioner V. Hawkes providing a Statement of OPP Activity in our area of policing jurisdiction for the calendar year 2017. The statement indicated at 893.75 hours of policing had been provided. Chief Nelson stated that he was aware of the information gathered was from self-reporting and could not account for the activity. He added that this is the second year that the OPP are forwarding these Statements to municipal police agencies, and suggested seeking an explanation of the activity from the OPP through the OAPSB.

# 4.7 Request for Disposal of Unclaimed and Found Property

A report was received from Inspector D. Pancoe seeking direction and authorization for the disposition of found and unclaimed gift cards, credit cards and corporate loyalty funds.

THAT the Brantford Police Services Board supports the recommendation of staff to dispose of unclaimed funds by donating them to Nova Vita

AND FURTHER that the Brantford Police Service be authorized to dispose of future unclaimed gift cards, credit cards and accumulated loyalty funds to a local charity within 30 days following the end of each calendar year.
