Deputy Chief Nelson highlighted areas of interest in this report. Although thefts of motor vehicles had increased, he indicated that Team Shutdown was now up and running again at full strength and was hopeful their efforts would address the problem. He also noted that thefts from motor vehicles had dramatically risen despite the efforts of the "Lock it or Lose It" media campaign. He was pleased to see a 25% decrease over 2011 in break and enters.

### 4.6 Taxi Bylaw #99-01

Mr. Philip Kuckyt, Manager of Transportation Services for the local school boards had requested the Board review the current wording in the Taxi Bylaw with respect to minimum insurance requirements and the need for a criminal record check and vulnerable sector screen for taxi drivers. Currently, the Board requires taxi owners to carry a minimum insurance level of \$1 million, and he requested the minimum be increased to \$2 million. Further, although criminal record checks and vulnerable sector screens are being conducted prior to a licence being issued, the taxi bylaw speaks in general terms. Staff supported these amendments.
