2.1 Partnership Project – Wilfrid Laurier University

Dr. Jennifer Lavoie, Dr. Carrie Sanders and Krystle Shore, MA graduate student, attended to request the Board consider becoming involved in a partnership research project with them, namely "Facilitating Collaborative Mental Health and Justice Services in the Community of Brantford".

Dr. Lavoie stated that fragmentation of the mental health service, coupled with the lack of community-based mental health service capacity, have not only created serious challenges for those living with mental disorders, but also for police services who have become the first point of contact.

The research goal would be to work collaboratively with key stakeholders to promote police/mental health collaboration in the hopes of improving the coordination of services.

The project will provide much needed evidence-based research on the current state of affairs and hopefully lead to develop innovative ways to address the problem collaboratively. Ms. Shores is currently working on an environmental scan, which will provide a description of the police response to calls for service involving people living with mental illness.

Dr. Sanders asked for the Board's support to apply for a \$200,000 grant under the Social Sciences and Humanities Research Council of Canada partnership development grant program. The Board would be required to assign a member to the research project who would be authorized to make decisions and identify deliverables.
