PURPOSE:

To provide the Brantford Police Services Board with an update on the status of construction at 344 Elgin Street.

BACKGROUND:

Construction continues at 344 Elgin Street and stakeholders continue to meet on a regular basis. The following information was reported by Melloul-Blamey on March 26, 2025:

Construction Activities Weeks of March 10 – 26, 2025:

Block A (3 Storey North Tower Addition)

- Parapet framing & steel stud wall framing continues
- Penthouse wall framing underway
- Penthouse roof installation started
- Electrical Conduit installations underway at 3rd floor
- Mechanical rough-ins and underground continuing

Block B (Garage Area, Detention Area, Generator Building)

- Exterior siding trims started
- Slab on grade complete at Generator Building
- Roofing installed at Generator Building
- Mechanical & Electrical rough-ins continue

- Cell block walls 80% complete
- Interior steel stud walls continuing

Construction Activities Anticipated April 2025:

Block A (3 Storey North Tower Addition)

- Final structural steel inspection scheduled
- Exterior steel stud framing & sheathing to continue
- Electrical conduit installations to continue
- Mechanical underground to be completed
- Clear stone deposit for ground floor
- Pouring concrete floor for 3rd floor
- Floor slab topping preparation

Block B (Garage Area, Detention Area, Generator Building)

- Mechanical & electrical rough-ins to continue
- Cell walls, tactical area walls & doors to continue
- Continue with siding clips & girts
- Masonry work to continue at shop area & generator building
- Cell deck installation, concrete topping to follow
- Rain-water leaders for Garage Area and Generator Building

These construction activities will continue into the end of April 2025. No delays of concern are expected.

The project remains on budget. The City has requested that the consultant review and monitor potential issues and complexities around tariffs, and cost avoidance has been realized for certain material orders. Value Engineering efforts are continually in progress.

PURPOSE:

To provide the Brantford Police Service Board with a high-level statistical report on the activities of the Service up to March 31, 2025.

BACKGROUND:

Most occurrences to date are in the "Assist" category (29.56%). The top three occurrences in this category are 9-1-1 calls (34.57%), compassion to locate (22.07%) and assist other service (11.72%). The remainder of the occurrences consist of various other types including missing person, child custody access and injured/sick persons.

Three occurrence types continue to trend upward when compared to the year-to-date historical average over five years; Theft of Motor Vehicles, Unwanted Persons and Fraud. The BPS continues to dedicate resources to address these occurrences, including,

- collaborating with local police agencies and participating in the Provincial Auto Theft and Towing (PATT) Unit to address motor vehicle theft,
- creating awareness of and providing fraud prevention education using social and print media, and
- increasing police visibility and presence through innovative techniques to address public disorder occurrences.

Occurrence data along with other reporting methods assist police to determine the most efficient use of police resources. Developing trends or changes are used by planners to develop programs and strategies to address public safety issues and crime preventions initiatives.

We are pleased to report the successful redevelopment of the Brantford Police Service's website, the first major update since 2017. The new website was redesigned with a focus on enhancing user experience, increasing access to information, and streamlining navigation through a simplified, modern interface.

Key Improvements and Features:

- **User-Friendly Design**: Simplified layout and intuitive navigation for easier access to resources.
- Enhanced Accessibility: Improved structure to better support users on all devices and comply with accessibility standards.


This redevelopment represents a meaningful step forward in transparency, communication, and public engagement. We look forward to continued improvements as we gather information and feedback from the community.

PURPOSE:

Implementation of the Provincial Bail Compliance Dashboard tool developed by O.P.P.

BACKGROUND:

The Provincial Bail Compliance Dashboard (PBCD) is a situational awareness tool, intended to provide policing partners with critical information regarding persons released on bail for firearm offenses within their jurisdiction.

The PBCD provides a visual dashboard for officers with spatial and near real-time information related to individuals in the community on bail for firearms offences, informing officer and public safety, as well as supporting the completion of bail compliance checks.

In response to the increasing concerns related to individuals on bail and the rising levels of serious and violent crime across the province, Toronto Police Services(TPS) pioneered the creation of a bail compliance dashboard for firearms offences, built on ESRI GIS technology with focus on efficient frontline usage. In partnership with Durham Regional Police Services, TPS evolved the dashboard application and data sharing model.

In May 2023, the Ontario Treasury Board asked the OPP to partner with the Toronto Police Service to build out this foundational work to support a Provincial model for all Ontario police services.

The OPP PBCD team is collaborating with partner ministries and law enforcement agencies to enhance and extend the current bail dashboard model pioneered by the Toronto Police Service to all Ontario law enforcement agencies.

PURPOSE:

To report on the status of funding requested by Chief Saunders for Court Security costs.

BACKGROUND:

In October of 2024, the Brantford Police Service requested consideration from the County of Brant to cover a portion of the City of Brantford costs to operate the court houses.

At that time, the proposed contribution was to cover a portion of the anticipated increase in 2025 operating expense, proportionate to the shared cost structure of other such services.

On April 3, 2025, Chief Saunders received notification that the County of Brant had agreed to contribute \$46,500 toward local court security costs.

We appreciate the County of Brant's willingness to supplement our costs and value our partnership with them moving forward.




2024 Canine calls for service


Our Canine teams responded to a total of **<u>124</u>** calls specifically relating to Canine in 2024. **This number does not include a very high volume of incidents where the teams attended to**

assist front line officers/platoons with regard to other call types. There were a total of <u>40</u> calls classified as Canine Use of Force incidents¹

A specific breakdown of Canine use/call-types and use of force can be found in the "Canine Use of Force" and "Calls for Service" sections contained within this report.




¹There were 3 apprehensions by bite in 2024 – which is the only use of force for a Canine PSD that would necessitate a Use of Force report.



2024 Canine Use of Force

A Canine apprehension falls under "intermediate weapons/options" on the Ontario Public-Police Interactions Training Aid (2023). As such they may be used for suspects exhibiting behaviour deemed to be *Active Resistant* to *Serious bodily Harm and Death*. In a tactical setting, the PSDs are an excellent tool that can be used to gain control of an armed suspect. This limits the risk undertaken by the PSD's human counterparts. The majority of Canine Use of Force incidents occur where the PSD is deployed for tactical containment, or used to supplement the Emergency Response Team resulting in a change of the suspect's behaviour. This is reflected as a displayed option in the graphs to follow.



In 2024, there were a total of forty (<u>40</u>) Canine specific calls classified as Canine Use of Force incidents. Canine apprehensions can be utilized for higher end *Active Resistant* suspects, and are typically present whenever possible for incidents involving *Serious bodily harm and death* (with proper lethal offset). Multiple force options are in place whenever possible to ensure only





as much force as is reasonable and necessary in the circumstances is used by our team and members. This has historically led to the safe conclusion of our higher risk incidents.

Of these 40 Canine use of force calls, the breakdown of use is as follows;


- Eighteen (<u>19</u>) incidents involved Canine as an additional *displayed use of force* option, typically to assist ERT (i.e. Pedestrian Takedowns, or weapons calls where an apprehension may be an option prior to lethal force (in conjunction with other force options).
- ♠ Four (<u>3</u>) incidents involved apprehensions by bite. These incidents can be found under; BR24012809, BR24015385, and BR24045253
- The remaining twenty six (<u>18</u>) incidents involved Canine use in tactical settings. The majority of these is for containment purposes while the ERT conducts entries (either planned or spontaneous).

Typically upon Canine arrival and deployment, suspect(s) will de-escalate their behaviour. A "displayed" (use of force) Canine deployment almost always reduces the need for further force. This in turn provides greater safety for our police members and the suspect.



2024 Use of Force Analysis

In 2024, three (3) apprehensions by bite occurred. The following graph shows the effectiveness of Canine showing **displayed force** (or presence) vs. **apprehension** (actual force used by PSD):



A breakdown of Canine calls for service

In the 2023 year, the Canine teams moved to 12 hour "night" shifts from 3:00pm – 3am (with the exception of training occurring on every other Wednesday). They teams now effectively work day shifts (08:00-18:00) and night shifts (15:00-03:00) This was in attempts to reduce call-back overtime and utilize the Canine teams more effectively when more use of force and violent crimes typically occur (after analyzing previous year Use of Force and Canine calls for service for the Brantford Police Service as a whole). With only two Canine teams in use by our service, we must make every attempt to be fiscally responsible and to not exhaust the teams with constant overtime.

In 2024, the majority of Canine calls occurred during the Night shift. This is consistent with previous years. Day shift calls occur at a reduced number. It is important to note that the


dayshift Canine calls are typically occurring primarily due to; a Canine team being available during dayshift training, and/or during planned early morning/daytime hours for ERT operations (they would normally not be called out for the incident).

In 2024, our Canine teams were called out to assist other services on 4 occasions. These services included; Six Nations Police Service (1 incidents), Waterloo Regional Police Service (2), and the Woodstock Police Service (1)


Out of a total of <u>124</u> Canine specific incidents, the following graphs show breakdowns for shift type, day of the week, and specific call types:

Dayshift: <u>24</u>


Night shift: <u>100</u>



As shown above, the majority of Canine calls occur during our Night shift hours. This has been consistent for many years (with the new night shift hours absorbing the former afternoon shift hours) and follows the Use of Force statistics for the service.






*Note: Sunday calls for service consist primarily of late Saturday night incidents


In 2024 the Canine teams were used for a variety of purposes. The general breakdown for Canine specific calls is as follows (*note: Multiple uses may be shown below for incidents such as assisting with high risk arrest, then subsequent detection work. This makes the total more than the 124 calls for service*):





*NOTE: During K9 deployments, the teams typically conduct several tactics (ie: assist with Tactical containment, then conduct detection at the conclusion of the event)

"Tactical use" continues to increase due to planned operations, the successful integration of ERT and Canine, and the availability of the Canine members during spontaneous higher risk incidents. This category covers off Emergency Response Team operations to support Major Crime, the Tactical Intelligence Generating and Enforcement Response unit, and other sections. With the inception of TIGER and HEAT, and the dramatic increase in firearms and violent crime, Canine teams are utilized more often to assist with *Containment* and other tactical options such as *Pedestrian Takedowns*.



Canine Team Activity Reports

For every canine call for service, our handlers complete a Canine Team Activity Report. These reports are maintained by the Canine coordinator. For quick reference for the Canine unit, a synopsis of each event is recorded electronically.

Ongoing training

The Canine teams conduct regular training and attend courses and seminars as the opportunity presents itself. Canine also has regularly scheduled training with the ERT to ensure interoperability during high risk incidents.

For the 2024 year, the training of our Canine teams was continued by our Canine Consultant/Trainer, Lance Montigny. Throughout 2024, Lance Montigny has provided constant, consistent, and highly effective training to our Canine teams and for our ERT members during integration training. This training has had an unmeasurably positive impact on the success of our Canine teams and ERT by improving the confidence of each team in their existing abilities, and has been instrumental in developing further skills. The changes observed with Lance Montigny have been overwhelmingly positive and have shown consistent and solid results. As the dogs age/mature (and through this constant and regimented training) they are becoming more and more proficient at any task at hand.

The structure of the training enables our Canine teams to train alongside teams from other PRIDE services including Guelph Police Service and the Waterloo Regional Police Service. There is also regular maintenance training conducted with the Halton Regional Police Service, and the Windsor Police Service.

Our Canine teams are very dedicated and they train and work together on a daily basis (both on and off duty) in order to maintain their skills. The two Canine teams train together a minimum of two days per month, however the actual number is closer to three days on average. During regular training, the teams train with the Emergency Response Team on; Pedestrian Takedowns, Open field movements and High risk tracking/area searches, and Building search






Joint K9/Tactical scenarios during the 2023 Tactical/Canine integration workshop

OVERVIEW

This report has been prepared by Sergeant Chris Grantham, the Officer in Charge of the Training Unit. This report consists of data collected from the ministry required Use of Force reports submitted by members involved in higher risk incidents involving the use of force. This force may consist of actual or demonstrated force.

Great effort has been made to emphasize statistics and year-by-year comparisons. This will ensure that our Senior Staff members and the Police Services Board receive an unbiased report.

All of the involved Use of Force reports have been reviewed by a trained use of force analyst and have been found to be justified. Reports are audited to ensure compliance with the Criminal Code of Canada, Ontario Policing Standards, and policies and procedures of the Brantford Police Service.

Reports are submitted by individual members based on their own perceptions of the incident. If a use of force incident involves the Emergency Response Team when deployed as a team, one report is submitted for the actions of the entire team (unless specific force is undertaken by a member). The ministry has also expanded "team" reports which will affect statistics on individual use of force reports submitted for 2025.

All use of force utilized during the 2024 year met the "Three branch test". This means that the actions taken of our members in the circumstances are **Lawful**, **Necessary**, and **Proportionate**.

Training Unit members are dedicated to the consistent delivery of mandated and optional training to ensure the safety of our members and ultimately the community we serve.

USE OF FORCE TRAINING

Regulations under the Community Safety and Policing Act outline approved use of force weapons, training, reporting, and technical specifications of equipment.

All active, sworn members of the Brantford Police Service receive annual refresher Use of Force training as per the Regulation. Training consists of the following topics per year (every 12 months):

Officer Safety	De-escalation & Tactical Communications
Mental Illness	Firearms
Hard & Soft Control Techniques	Judgment
Police Vehicle Operations	Intermediate Weapons (OC, ASP Batons and CEW's)

All training is developed, created, and evaluated by members of the Training Unit. Individual members are evaluated based on the training standard. All of our members must demonstrate proficiency in all areas in order to successfully complete the yearly training. Failing to meet standards in any area will result in additional or remedial training in order to meet or exceed the prescribed standard. **The goal of the Training Unit is to continue exceeding standards for our members to ensure officer and public safety for our community.**

In addition to Ministry mandated training, all sworn members and Special Constables receive skill development and refresher training on a number of topics that may vary slightly year by year. These additional topics include (but are not limited to) Immediate Rapid Deployment, basic first aid, CPR, advanced medical care, cultural awareness, traffic and radar updates, and crime scene management.

USE OF FORCE REPORTING

The following guidelines under Regulation O. Reg 391/23 (Use of Force) of the Community Safety and Policing Act of Ontario outline when officers SHALL submit a use of force report:

Use of force reporting — members of police service

13. (1) Subject to sections 15 and 16, a member of a police service shall submit a report to the chief of police whenever the member,

(a) draws a handgun in the presence of a member of the public;

(b) points a firearm at a person;

(c) discharges a firearm;

(d) uses a weapon on another person;

(e) draws and displays a conducted energy weapon to a person with the intention of achieving compliance;

(f) points a conducted energy weapon at a person;

(g) discharges a conducted energy weapon; or

(h) uses force on another person, including through the use of a horse or a dog, that results in an injury requiring the services of a physician, nurse or paramedic and the member is aware that the injury required such services before the member goes off-duty.

This report also contains information under 2024 Brantford Police Service Policy which further required members to submit a Use of Force Report when:

- A member demonstrates a Use of Force option
- A member of the Emergency Response Team or qualified Patrol Officer displays a carbine rifle operationally while on duty in view of the public

These reports were tracked initially and earlier in the 2024 year, then were removed due to the service removing itself from CALEA accreditation.

When a use of force incident meets the threshold for report submission, the involved member completes the report and submits it to an NCO for review. The report is then forwarded to a qualified

Training Officer/Analyst to ensure the use of force is appropriate, legal, and justified. The analyst's review is then forwarded up the chain of command to the Inspector of Quality Assurance.

RACE DATA COLLECTION

The Anti-Racism Act created legislative framework in Ontario to combat systemic racism and advance racial equality. Under this legislation, the Ministry of the Solicitor General required Police Officers to record race data in use of force incidents starting January 1, 2020. This requirement meets Ontario's Anti-Racism Data Standards and ensures consistent and effective practices are in place for reliable information gathering, decision making, and public accountability. Race data collected during 2024 will be summarized below in the appropriate section.







Total number of use of force reports submitted for 2024:




The graph below compares the number of use of force incidents to the number of use of force reports submitted in 2024.



USE OF FORCE BY DAY OF THE WEEK AND TIME



The following graphs break down when use of force incidents occurred; by day of the week, and by time (shift).




USE OF FORCE BREAKDOWN BY DAY OF THE WEEK




USE OF FORCE INCIDENTS BY PATROL ZONE

The City of Brantford is divided into five patrol zones based on geographical boundaries. The zones are defined as 410, 420, 430, 440 and CORE (downtown core). The following graph outlines use of force by zone.



The zone classified as "other" denotes areas outside of the City of Brantford. This statistic was captured by the ERT after assisting an out-of-town service for high-risk warrant executions. As shown above, 430 zone maintains the majority of use of force incidents. The fact that 430 zone has the most calls for service regarding use of force has remained unchanged for a number of years.

USE OF FORCE BY OFFICER EXPERIENCE



Members with less than one to two years, and six to ten years of experience represented the most use of force reports. Members with **less than ten years** total service account for **75 percent** of all use of force incidents. This is not surprising as the majority of these members are uniform patrol, sworn frontline officers. Members with ten or more years of service were responsible for 25 percent of all reports.

Emergency Response Team Statistics

Emergency Response Team members accounted for 74 individual Use of Force reports = 27.1%

Emergency Response Team operations resulted in 27 team reports = 9.8 %



Non-Emergency Response Team members submitted 177 reports = **63.1** %

These numbers are typical of previous years. The Emergency Response Team consists of 14 sworn members who routinely attend and take the lead during high-risk incidents where force is required/utilized.

USE OF FORCE BY OFFICER ASSIGNMENT

The following graph provides a breakdown based on individual officer assignments. General Patrol or Platoon members accounted for 63.1 percent of all use of force reports. The remainder are divided between support units such as traffic, BEATS and Plainclothes units (DFEU and CIS).

Starting in January of 2025, ERT members will be captured under "Tactical Team" with the move to Tactical Status for the ERT.

USE OF FORCE BY LOCATION (INDOOR VS OUTDOOR)

Use of force incidents can occur anywhere. The following charts outline where use of force incidents occurred. The number of locations will be greater than the number of use of force reports submitted. This is due to the fact that some incidents are fluid and move from place to place (example; a use of force incident may start in a yard and continue into a residence. In this case, both locations are captured for statistical purposes).

The two general categories for locations of incident are either "Indoor" or "Outdoor". Each category is broken down further and will be displayed in the charts below.

USE OF FORCE BY INCIDENT TYPE


The following information relates to a member's belief of the type of call they were responding to. Some incidents may have multiple incident types depending on the specific occurrence.

Many members will classify an incident as a weapons call if a weapon is reported to be present (regardless of the manner in which it is being used). As a result, incident classification can be skewed to represent categories higher than what they truly are.

USE OF FORCE - DISTANCE TO SUBJECT

The following graph outlines the distance from the subject when the decision to use force was made by the member.



Our members continue to make decisions to utilize force options at greater distances. This demonstrates pre-planning, which is strongly encouraged through all service training. These decisions are based on complainant information, dispatch communications, and member experience. Typically, the closer ranges represent a spontaneous attack, or a shift of subject actions where a member is required to take action.

USE OF FORCE - TYPE OF FORCE USED


This section deals with options used by our members during a use of force incident.

Our service did not have any firearm discharge that resulted in the injury or death of a subject. We did have one "shots out" call where a member discharged their firearm at a motor vehicle that represented a threat of *Serious Bodily Harm and Death*. The subject was not struck by gunfire and our member was cleared by the Special Investigations Unit of any wrongdoing (<u>SIU Report 24-OFP-012</u>)

The ARWEN is an extended range less lethal option carried by trained ERT members. This less lethal option discharges a number of 37mm munitions (the most commonly used being a rubber projectile). **35 deployments** were recorded in 2024, with **34 incidents of demonstrated** (pointed), and **1 discharge** causing minor injuries. The discharge incident was investigated by the Special Investigations Unit with the members cleared of any wrongdoing (<u>SIU Report 24-OFP-439</u>)

Conducted Energy Weapon deployments are covered in the "Conducted Energy Weapon Analysis" section of this document.

Oleoresin Capsicum (OC Spray) was **discharged once in 2024**. This was an ERT deployment deemed effective and did not result in any injuries.



An ASP Baton was not used by any members in 2024.



USE OF FORCE AND DEESCALATION

De-escalation attempts were utilized in all reported use of force incidents for 2024, unless there was an imminent threat, or if action was required immediately. These attempts utilized Communication, Containment, Cover, Time, Distance, Repositioning, Teamwork, and Time. Out of the 150 use of force incidents, 160 had de-escalation attempts (accounting for the fact that multiple members attending attempted this tactic).

USE OF FORCE - WEAPONS CARRIED BY SUBJECT

The following chart depicts weapons that were believed to have been carried by subjects. It is important to note that the information below is based on what the member perceived at the time they decided to use force, not by what they later determined to be fact.




The perceptions and incidents of subjects carrying firearms and other weapons continue to remain and grow steadily, specifically with firearms.



USE OF FORCE INCIDENTS - INJURIES

The following graph shows the number of injuries as a result of use of force encounters.

Injuries are categorized as either minor, serious, or fatal. A minor injury is referred to as an injury that requires medical attention. A serious injury refers to an injury that requires hospitalization. A fatal injury refers to a loss of life. All injuries received during 2024 were deemed minor in nature. No serious injuries or death occurred in 2024 resulting in a Special Investigations Unit investigation.




USE OF FORCE - RACE COLLECTION DATA

In keeping with Ontario's Anti-Racism Strategic Plan, all members were required to identify race data for each subject involved in a use of force interaction. Race has been divided into the following categories: White, Black, Latino, South Asian, Indigenous, Middle Eastern, East/Southeast Asian, and gender (male/female). It is important to note that the data collected represents what the member believed the subject's race to be when the decision to use force was made, not what it was found out to be after the incident.


It should be important to note that what is not captured in these statistics are subjects who attend from outside our community – other jurisdictions (such as the Greater Toronto Area) and are involved in a use of force encounter. As a result, these statistics may not necessarily reflect the real numbers on race vs police use of force by our service members.

In 2024, Brantford Police Service members interacted with 220 subjects during the 150 use of force incidents. This represents an average of 1.47 subjects per use of force call.




The following chart illustrates a breakdown of each subject by collected race data:

The following chart shows collected race data from the start of collection in 2020 – 2024. There are minor fluctuations however, the numbers appear quite consistent year by year.

The following chart illustrates gender data as collected. As with previous years, Male subjects represent the vast majority for force used with 90.7%.



2024 CONDUCTED ENERGY WEAPON ANALYSIS

The Conducted Energy Weapon (CEW) is a less-lethal use of force option carried by front line members. Since its deployment to front line members in 2014, it has been the primary choice of members in the majority of less lethal encounters. Following training, it is also widely utilized in incidents that present members with a lethal threat (*Serious bodily harm and death*). In these cases, lethal offset is in place.

Conducted Energy Weapons were reported to have been used **100 times** in the submitted use of force reports for 2024.

Our members undergo extensive annual CEW training including (but not limited to) the following:

- Legal issues and the Criminal Code sections on Use of Force
- The need to use an intermediate weapon and the Public-Police Interactions Training Aid (2023)
- Communication and De-escalation and the concept of one voice for commands and communication with the suspect/subject
- Proficiency in transition drills; Firearm, CEW, OC, Baton
- Proficiency in the use of the Taser 7 CEW; drawing and holstering, tilt select options, and types of cycles
- Blue on Blue, positioning, and the use of barriers for officer safety
- A team approach to tactics and arrest team tactics and handcuffing
- The importance of control under power and/or breaks in the applications to determine levels of cooperation (and ability to comply with commands)
- CEW probe deployments on a live target utilizing the HALT suit (and associated cartridges) to enhance comfort and skills on the device



The CEW was drawn & displayed to achieve compliance 45 times in 2024



The CEW was drawn & pointed 45 times in 2024



The CEW was discharged 10 times in 2024. CEW discharges are broken down into probe deployments and drive stuns. Probe deployments accounted for 8 CEW discharges. In several incidents, probe deployments were attempted more than once in order to assist in gaining control of a subject. There were only 2 incidents involving Drive Stuns.

SUMMARY

In 2024 there was a slight decrease in calls for service when compared to 2023, dropping from 57,644 to 55,213. During the previous five years, the calls for service have increased in a fairly consistent manner as the city continues to grow.

Use of Force incidents have dropped slightly in 2024 however they continue in a gradual upward trend when examining year-to-year statistics. This gradual increase appears to match the proportional increase in population and calls for service. It is important to note that historically, our jurisdiction has an overall higher crime rate and violent Crime Severity Index on a consistent basis as reported by Statistics Canada.

With the 150 use of force incidents out of the total 55,213 calls for service it can be stated that our members utilized force a very small fraction of the time during interactions with our community members. During these interactions force was used only .271% of the time. This falls in line with and well below the Provincial statistic of "below 1%".

As with previous years, the data collected shows that our members demonstrated professionalism and restraint when called upon to deal with higher risk incidents. With the limited injuries and use of force per community interaction, force (whether actual or demonstrated) is used in a very small fraction of calls. Our members have clearly demonstrated that they use force only when it is required (necessary) and that this force utilized is both reasonable and proportionate in the circumstances.

PURPOSE:

To provide the Police Services Board with an update on public complaints submitted to the Law Enforcement Complaints Agency (LECA) during the first quarter of 2025.


LECA accepts complaints from members of the public about the conduct of police officers.


BACKGROUND:

In the first quarter of 2025 (January to March), 34 public complaints were submitted to LECA against the Brantford Police Service.

Twenty-one of these public complaints were "screened-out" by LECA and required no further action. A total of 13 public complaints were "screened-in". Of these, four complaints were resolved using alternative methods, one complaint was investigated and found to be unsubstantiated, and eight complaints remain ongoing.

For comparison, in Q1 of 2024, a total of 16 public complaints were made against the Brantford Police Service. LECA complaints have doubled in Q1 of 2025 when compared to last year. This increase is believed to be a result of citizens becoming more familiar and aware of LECA and the public complaints process under the new *Community Safety and Policing Act.*
